- · Make sure to test the operation of the product after setting with the DIP Switch to verify that the product operates as intended.



Mounting Procedure

- 1. Remove the Cap (terminal connector) from the socket of the receiver body of the F3SG-RA Safety Light Curtain. Then insert the connector of the product to the socket.
- 2. Securely tighten the screw (M2.5, recommended torque: 0.35N·m).




How To Use
